Due to the current fuel situation Thai Airways International wishes to advise a **Q surcharge** to be implemented for **ticketing on/after 01 April 2026** until further notice.

The Q-surcharge will apply to all fare types, all cabin classes on TG-operated flights including Royal Orchid Plus redemption tickets with the exception of:

- unrestricted fares
- Rule 7000 fares with suffix -YRTG/-YOTG
- Rule 7777 fares with suffix -FFTG).
